There was discussion on contractual language by Corporation counsel regarding the insurance coverage being too low. He added that nothing needed to be done on this contract until fall of 2011. Supervisor Sumpter asked if this was the first or second extension of the contract and Ms. Kirsenlohr responded this was the second extension. Sheriff Elect Sam Wollin was asked for input and stated he could not comment on this. Motions by Sumpter/Ward to renew the contract for six years. Chairperson Sebastiani called for a roll call vote on this motion. Sumpter/Ward, voted "Aye", Sebastiani/James voted "Nye". At 5:38 there was a motion to adjourn by James/Ward. At 5:40 Supervisor Keckeisen arrived at the meeting. A motion by Keckeisen was made at this time to bring back the contract vote at 5:42 pm. Keckeisen indicated he would vote "Nye". Keckeisen/Sebastiani/James – "Ney", Ward/Sumpter, "Aye".
